- 1. You are responsible for the **Ford Entegra Odyssey, 2020, 8NAU221**, both inside and out.

You acknowledge and agree:

- 2. Campground Reservations: We are not responsible for campground reservations. All campground reservations must be made separately with the campground’s reservation agency. All campground and campsite fees are separate from and in addition to the rental price and fees under this Agreement. No refunds will be given for campsite reservation errors.
- 3. **MOTORIZED AWNING:** I understand that awning damage is not covered by insurance and can be up to \$5000 to repair or replace depending on the damage. I understand that if I choose to use the motorized awning and it is damaged during my rental period, I assume the cost of any damages not covered by insurance. I understand that to avoid damage it has been explained to me to never leaving the awning extended out during rain, wind, when left unattended or overnight. I understand that these factors alone do not guarantee freedom from damage but will help to prevent it. I also understand that for my own safety I agree to these terms because in a windy situation the awning could act as a sail and tip the entire RV over and put myself and my friends/family at risk. You as the Renter understand use of awning is at my own risk and any damages for whatever reason are going to be deducted from my damage/security deposit *We strongly recommend you **DO NOT** use the awning at all but if you do remember any damage is 100% paid for out of your damage deposit.
- 4. **TIRE DAMAGE:** You as the renter understand that when renting a drivable RV, any tire damage during a rental is your responsibility. Tire must be repaired by a certified tire shop with the same tire brand if possible or its equivalent.
- 5. **THINGS HAPPEN AND WE TRY TO HELP:** Plain and simple things happen. RV’s break and sometimes things do not work. When “things happen”, misc. water issues, air conditioner freezes from running too much and needs to defrost, a RV isn’t cleaned to your standards and other misc. items I **AGREE TO WORK WITH** Julia and Mark Keiser **AND HELP THEM TROUBLE SHOOT ISSUES AS THEY ARISE.** Obviously, we want happy customers and repeat business, so we take this privilege to make those judgment calls serious. Let us say you do not have hot water in the shower, and we are not able to trouble shoot. **WE DO NOT** typically refund more than \$100 for these inconveniences. There are rare situations we do. You are renting a place to sleep, and you are camping. If one of the situations mentioned above is unacceptable to you and you cannot adapt when thing happen than please let us know.
- 6. **MISSING, STOLEN, or BROKEN ITEMS:** Please always keep camper key with you when away from the RV. Be sure to lock the RV when you step away and do not leave small children unattended inside the camper. You are responsible for missing, broken, or stolen items. We will go over an inventory list with you during walkthrough. Any item missing or damaged upon return of vehicle will be taken out of your security deposit.
- 7. **APPLIANCES:** The A/C, heat, awning, radio, microwave, television, jacks, plumbing, etc. are convenience items. If any malfunctions should occur with any of these items, no compensation will be made to you, but we will work to try and get issues addressed while the rental is underway. For assistance, you are advised to consult the campground host which are located at most campgrounds or give us a call 951-776-7276 (Julia) or 951-741-0799 (Mark).
- 8. **PROCESSING FEE:** A fee of 2.95% will be added to all misc. charges such as mileage fee, generator usage fee, damage fee, late return fee, etc. to cover time and credit card processing fees.
- 9. **CLEANING:** RV will be inspected, sanitized, and cleaned when you get it with **EMPTY** Black tank. We **DO NOT** charge any cleaning fees, all we ask is that the RV be returned in the same condition that you received it: microwave, cooktop, fridge and freezer, mirrors, toilet ball, shower pan, both sinks must be cleaned. Floors must be washed with the provided mop. If any DNA is left behind, and deep cleaning is required, appropriate charges will be deducted from your deposit at the rate of \$250.
- 10. **DO NOT** dump grease or food down the kitchen sink or toilet.
- 11. **RENTERS LIABILITY:** Renter agrees to accept liability for any damages caused to the Rental by renter or renter’s guests, including, but not limited to, damage to the Rental in any way or damage to any appliances and/or

equipment furnished. Use during freezing weather is completely at your risk regarding damages to any part of the water system and freezing. If damages are more than the security deposit being held, renter agrees to reimburse Mark Keiser for costs incurred to repair/replace damaged items. If renter is having the rental delivered renter accepts all responsibility and liability once rental is delivered by driver and until driver picks up rental.

- 12. RV PERFORMANCE: The RV is setup to run off specific electrical hookups. Julia and Mark Keiser will not be held responsible for the performance of your rental when you are not hooked up to the proper electrical setup which is 30amp shoreline power. If you are using a generator, 110 reducers, etc. the RV may not function the way it is intended. Julia and Mark Keiser will not be held liable for any performance issues of the rental when you are not setup at an actual campground. Houses, fairgrounds, fields, and empty lots would be an example of this.
- 13. SMOKING (including E-cigarettes): I understand that smoking inside the camper is strictly prohibited. I understand that at the owner’s discretion if there is evidence of smoking inside the camper, I forfeit my security deposit in its entirety.
- 14. PICK UP AGREEMENT: I understand that it is my responsibility to have the RV unpacked of my belongings and the returned to the same condition it was delivered in by the agreed upon pick up time.
- 15. ROOF access is strictly prohibited, if evidence of someone on the roof you (as the renter) will be charged half of your deposit, no exceptions.
- 16. KEYS: I understand that RV keys cannot always be copied. If the keys to the RV are lost this may require locks being changed. I understand that if the keys to the RV are lost, I forfeit up to 50% of my security deposit
- 17. You as the renter are responsible for all items in the RV such as: toaster, coffee maker, RV navigator, Wi-Fi Booster, storage hitch, TV remotes, BBQ, etc. Any damage inside or out is your responsibility
- 18. No Drugs or fireworks in the vehicle.
- 19. No Animals in the vehicle unless agreed upon by renter and owner.
- 20. You as the renter are responsible for the entire content of the RV, even if you did not utilize. Please check the contents at the walk thoroughly prior to taking possession.
- 21. I understand that RV is equipped with on-board GPS tracker. It monitors location, speed, sharp turns. Removing it will forfeit 100% of your security deposit.
- 22. DO NOT drive faster than 65 mph.
- 23. DO NOT hookup RV if you are standing in water.
- 24. DO NOT plug in or unplug from hookup while generator is running.
- 25. I understand that the RV is designed to properly operate by being plugged into 30-amp service or ran by the onboard generator.
- 26. I understand that A/C can only drop the temperature down about 20 degrees lower than outside temperature.
- 27. I Understand that Slide Out can be used ONLY when RV is parked on a level surface.
- 28. I understand that fridge performance can be unsatisfactory if temperature outside is more than 90 degrees.
- 29. I understand that ONLY 5 people can travel in moving RV.
- 30. I understand that beds, overhead bunks, sofa, dinette, or chairs NOT equipped with seat belts or factory restraint systems are not safe to occupy while the vehicle is in motion.
- 31. SECURE any loose object prior to movement of the vehicle.
- 32. ALWAYS use a lookout when backing vehicle even if equipped with rear monitor or backup camera.
- 33. BE AWARE of the total height of your vehicle, including roof mounted accessories, and verify clearance of any low object before attempting to pass beneath.
- 34. SHOWERS and tubs are slippery when wet and not for utilization while coach is in motion.
- 35. TOILET & SEWER: I understand that nothing other than the provided toilet paper, sewer treatment pods, and cleaner are to be placed in the toilet or down the sewer. This includes and is not limited to feminine products (Tampons and pads), paper towels, trash, plastic, and any foreign object. I understand that I can be charged up to \$2000 to repair any damage to either system.
- 36. Do NOT attempt to fix damage yourselves. It is your responsibility to notify us, the owners, of any damage immediately. If the potential repair is minor, you may make the repair only after consulting us. Replacement of

defective parts and receipt must be brought back for reimbursement. There will be NO reimbursement if you do not bring back the defective part you replaced and the receipt. If you purchase an item necessary due to an equipment failure (sewer or water hose, ice chest, etc.) the item you purchased and the receipt must be surrendered upon return if you want reimbursement.

- 37. NEVER attempt to change vehicle tires, ALWAYS contact a professional tire facility qualified for this operation.
- 38. DISCONTINUE travel during high wind conditions.
- 39. Personal Property: You release Julia and Mark Keiser from all claims for loss of, or damage to your personal property or that of any other person that was in the RV.
- 40. Personal Injury: You release Julia and Mark Keiser from all claims for injury, including, without limitation, personal, bodily, or mental injury, economic loss or damage to you, guests, unborn children, or relatives, whether or not the injury was caused by use of the RV.
- 41. Severability: If any provision of this Agreement is judicially determined to be invalid, void, or unenforceable, the remaining provisions shall remain in full force and effect.
- 42. Attorneys’ Fees: In the event a dispute arises regarding this Agreement, the prevailing party shall be entitled to recover its reasonable attorneys’ fees and costs, in addition to other relief to which it is entitled.
- 43. Modifications: No term of this Agreement can be waived or modified except by a writing that we have signed.
- 44. Entire Agreement: This Agreement constitutes the entire agreement between the parties regarding the rental of the RV, and supersedes all prior oral or written agreements or understandings regarding this subject matter. This Agreement can only be amended by a writing signed by all parties.
- 45. Renter should not abandon the RV. There are certain return documents that Renter must sign to complete the transaction. Therefore, Renter’s presence at drop off is required. Abandoning the will waive Renter’s rights to entire deposit, as well as waive the right to any claims due to damages or vandalism, which may occur because of travel trailer’s abandonment.
- 46. UNDER NO CIRCUMSTANCE can departure or return of RV be after 6PM. We cannot do a proper walk through after dark. EXTRA CHARGES WILL APPLY.
- 47. If you choose to leave your personal vehicle parked at our property, you understand that Julia and Mark Keiser are not responsible for your personal vehicle safety.
- 48. I understand that I am responsible for the RV, **Ford Entegra Odyssey, 2020, 8NAU221**, will return it condition it was rented to me. I understand that if items are damaged, broken or missing I am responsible.

PET POLICY:

- 1. **Pet Health:** owner is responsible to make sure that: Vaccinations (including rabies) are up to date; Pet is free from fleas and ticks ; Pet is safe to travel to your desired destination; Pet is free from infections or contagious harmful to other pets.
- 2. **NO Leaving Pets in RV Rental Unattended:** Leaving a pet in a vehicle unattended in our RV Rental is a health hazard to your pet, a damage hazard to the RV and a possible noise issue for your camping neighbors should your pet become distressed. We strictly forbid any animals left unattended for any duration of time, period in our RV Rentals.
- 3. **Maximum # of Pets: 2.** All dogs must be approved prior to departure and we never allow more than 2 pets.
- 4. RV Owner assume no responsibility for illness or injury that may occur to pets or humans during the RV rental period or because of the contracted RV rental. The pet owner hereby assumes all responsibility and shall be solely responsible for the pet and its behavior while a guest in the contracted RV and during the entire RV rental period.
- 5. We advise all animals to be leashed any time the pet has exited the RV rental and should be restrained or crated while inside the RV rental to prevent injury to others or to the pet(s) themselves.
- 6. Further, fleas and ticks are a fact of nature and can be very prolific out in nature. We request that all pets be treated with a topical flea and tick repellent (3) days prior to departure to keep the pet from attracting pests and to help us keep our RV rental free from flea or tick infestation. This is a good practice for you and your pet safety

Drugs	Storage, transportation, or use of illegal substances will forfeit your entire security deposit. RVs returned with any evidence of drug use or transportation will result in law enforcement being called for a report and to collect the evidence.	\$1500
Black and Grey Tanks	Black and Grey tanks MUST BE EMPTY when RV returned. Charge will apply if tanks are not emptied before return. ALWAYS empty the Black Tank first, and only after that- the Grey Tank.	\$100
Mileage	100 miles per day is free. Charged \$0.55/mile if over	\$0.55/mile
Generator	If over 3.5hrs/day. RV generators are for running the central A/C and temporary power while traveling. These are not "constant run" generators and are not designed or allowed to be used as primary power while you are camping by running them constantly for extended periods of time. Before opening awning, get out and check for obstruction. NEVER move the RV with the awning out. Slide Out	Slide will ONLY work when motorhome is leveled on already somewhat level surface. Always set leveling jacks first prior to extending the slide.
